#### INTRODUCTION

The FSSC 22000 certificates shall be based on the templates in this Annex.

The content of the certificate shall match the template and requirements in Part 3, section 7.2 of the Scheme.

The layout of the certificate is at the discretion of the CB.

Where the certified organization requires a copy of the FSSC 22000 certificate in another language, the following requirements shall be met:

- a) The English certificate remains the original and valid version of the certificate and is the one uploaded to the Portal;
- b) The translated copy of the certificate shall be a complete and true representation of the English version and meeting the requirements of this Annex;
- c) The CB shall have a system in place to manage translated copies of certificates and ensure translations are correct and accurate.
