The FSSC 24000 Scheme is a social management system standard developed to assist organizations in the consumer goods industry and the related supply chain in meeting social sustainability and performance requirements. It incorporates the recognized, independent PAS 24000: Specification for Social Management Systems, which includes social performance requirements.

Social performance includes decent work, business ethics requirements, and application of due diligence in the supply chain. These challenges can be addressed through an effective and recognized social management system such as FSSC 24000, that has been aligned with the ISO Management System Approach, requires accredited third-party certification and is governed by an independant non-profit Foundation.



BENEFITS OF FSSC 24000 CERTIFICATION

- Governing Supply Chain
 Management: The FSSC

 for integrated, reliable, and

 processes for governing supply
 chain management. It targets an
 organization's human and labour
 rights aspects by setting policies,
 procedures, and risk assessments
 on a social management system.
- Market acceptance and commitment: The FSSC 24000
 Scheme is benchmarked by the Sustainable Supply Chain Initiative (SSCI) for global recognition. The SSCI is part of the Consumer Goods Forum Coalitions of Action to build trust in sustainability certification schemes worldwide.
- FSSC 24000 Scheme supports the continuous improvement process, enabling organizations to identify long-term actions that satisfy social performance expectations, including those mandated by legislations, such

- By monitoring, measuring, analyzing, and evaluating the performance of the management system, an organization can generate data to support transparency and continuous reporting on social performance, particularly in relations to human and labour rights aspects in the supply chain (as needed for the Corporate Sustainability Reporting Directive).




- Trust: Delivers high-quality and consistent audits monitored by the robust FSSC Integrity Program and assured by licensed Certification Bodies and qualified auditors.
- **Enhances visibility** through the publicly available register of Certified Organizations on the FSSC website.
- Providing an alternative solution: FSSC 24000 fully incorporates the PAS 24000, which addresses social management and social performance requirements, with the added FSSC 24000 Scheme requirements that ensures consistency, integrity and effective governance of the audit and certification processes.
- It is also possible for organizations holding other third-party accredited social certifications, or SSCI recognized programs, to transition to FSSC 24000 with the added benefit of potential audit duration reduction.
- Integrated management approach: Facilitates the integration of social management with other risk-based management systems, such as those governing food safety (FSSC 22000), quality (ISO 9001), and environmental (ISO 14001).
- The Scheme is governed by the non-profit
 Foundation FSSC and overseen by an independent Board of Stakeholders.
