# 1 COOKIE POLICY

This Cookie Policy was last updated on 03-04-2024.

## 1.1 WHAT ARE COOKIES?

A cookie is a small simple file that is sent along with pages of this website and stored by your browser on the hard drive of your computer or another device. The information stored therein may be returned to our servers or to the servers of the relevant third parties during a subsequent visit.

### 1.1.2 FUNCTIONAL COOKIES

Some cookies ensure that certain parts of the website work properly and that your user preferences remain known. By placing functional cookies, we make it easier for you to visit our website. This way, you do not need to repeatedly enter the same information when visiting our website and, for example, the items remain in your shopping cart until you have paid.

You may find surveys on our website. When answering these surveys, our supplier Survicate will use Local Storage to store the follow (functional) information:

- Visitor ID
- Visitor attributes passed using traits or survey URL
- Survey status (displayed and answered surveys)
- Tags

Survey responses given by specific respondent queued to be sent to Survicate (deleted after the answer is sent). We may place these cookies without your consent.

### 1.1.3 STATISTICS COOKIES

We use statistics cookies to optimize the website experience for our users. With these statistics cookies we get insights in the usage of our website.

### 1.1.4 MARKETING/TRACKING COOKIES

We might use marketing cookies on this website, enabling us to gain insights into the campaign results. This occurs using a profile we create based on your behavior when visiting FSSC.com. With these cookies, you, as a website visitor, are linked to a unique ID.

## 1.3 CONSENT

When you visit our website for the first time, we will show you a pop-up with an explanation about cookies. If you choose "Only functional cookies" we only process cookies needed for log-in. We choose to ask explicit consent for the use of statistics cookies.



If you give us your consent to process your data, you have the right to revoke that consent and to have your personal data deleted. You can change your preferences on this page via Manage Cookie Consent button.

## **1.4 DELETING COOKIES**
